# FortiSASE SIA Agent-Based Rapid Deployment

## **SERVICE OVERVIEW**

CDW's FortiSASE SIA Agent-Based Rapid Deployment service allows customers to quickly provision and start their FortiSASE journey and begin seeing returns on their security investment sooner.

Secure internet access (SIA) for agent-based remote users is the most typical use case involving the installation and configuration of FortiClient on supported endpoints (including Windows, macOS and Linux endpoints). For this use case, the FortiSASE firewall-as-a-service (FWaaS) comes between the endpoint and the internet by establishing a full-tunnel secure sockets layer VPN (SSL VPN) between the client and the FWaaS. The agent-based SIA secures all internet traffic and protocols using VPN policies by connecting each endpoint to a Fortinet point of presence (PoP).
