CO₂ EMISSIONS AWARENESS

The Brother Group is committed to reducing CO₂ emissions of the entire value chain in all its business operations by 2050 and contributing to creating a carbon-free society, which is a mission for the global community.

Many copier or print manufacturers require onsite service or repairs each time a device breaks down or malfunctions, which means a service technician can be driving back and forth to the site regularly over the life of a product.

The more times a device requires onsite service, the more times a technician may need to travel to and from a company. This travel may use unnecessary gas and if traveling by car, may also create CO₂ waste emissions for multiple car trips.

Should the device need to be replaced, as an alternative, priority Brother customers and customers who purchase an extended limited warranty are eligible for Priority Exchange, which offers overnight shipment of a replacement unit in the event of a defective Brother machine.

TONER AND INK CARTRIDGE RECYCLING PROGRAM

Brother offers a cartridge collection and recycling program for select Brother Genuine Supplies. Simply reuse the shipping box from a new Brother toner or ink cartridge to package and send back the used cartridge.
